Dear Claimant,

We received the Claim Form(s) you submitted in connection with *Precision Associates Inc., et al. v. Panalpina World Transport (Holding) Ltd., et al.*, also known as the Freight Forwarders Class Action Settlement. Upon reviewing your Claim Form(s), we found that one or more of your claim totals appear to be inconsistent with your Schedule B summary of all eligible freight forwarding costs, totaling <<\$\$\$\$>>.

- **INCONSISTENCY OF SHIPMENTS**: Upon review of your claim, your 1A, 1B, or 1C claim for total *count of shipments* is greater than or equal to your Schedule B summary of all eligible freight forwarding *costs*. 1A, 1B, or 1C represents the TOTAL NUMBER of air or ocean shipments, which should be significantly less than the cost of the shipments. Please provide a sworn statement explaining this inconsistency or revise your claim.
- **INCONSISTENCY OF WEIGHT**: Upon initial review of your claim, your 2A or 2B claim for total *pounds of air shipping* is greater than or equal to your Schedule B summary of all eligible freight forwarding *costs*, which should include costs for any air poundage claimed under question 2A or 2B. Please provide a sworn statement explaining this inconsistency or revise your claim.
- **INCONSISTENCY OF QUESTIONS 3A AND 3B**: Upon initial review of your claim, your 3A or 3B claim total is greater than your Schedule B summary of all eligible freight forwarding costs. The time periods, origins, and destinations per questions 3A and 3B typically represent a subset of the Schedule B summary. Please provide a sworn statement explaining this inconsistency or revise your claim.

Whether or not you revise your claim, please provide a sworn statement, either notarized or sworn under penalty of perjury, affirming your original or revised claim amounts, and include a copy of this letter with your response.
