**DECLARATION OF SIMON BAHNE PARIS IN SUPPORT OF
PLAINTIFFS' PETITION FOR ATTORNEYS' FEES
AND REIMBURSEMENT OF EXPENSES FILED ON BEHALF OF
SALTZ MONGELUZZI BARRETT & BENDESKY, PC**

I, Simon B. Paris, declare and state as follows:

1. I am a Partner of the law firm of Saltz Mongeluzzi Barrett & Bendesky, PC. I submit this Declaration in support of Plaintiffs' petition for an interim award of attorneys' fees and reimbursement of costs and expenses in connection with services rendered and expenses incurred by my firm in connection with this litigation.

2. My firm has acted as counsel to Plaintiffs and the Plaintiff class in this class action. During the period August 16, 2015 through July 31, 2016, and at the request of Plaintiffs' Co-Lead Counsel, my firm has been involved in the following activities on behalf of the Plaintiffs:

- Document review of DHL documents.

3. The schedule attached hereto as Exhibit 1 is a detailed summary indicating the amount of time spent by the partners, attorneys and other professional support staff of my firm who have been involved in this litigation, and the lodestar calculation is based on my firm's

current hourly billing rates except for work done on document review which is capped at \$400 per hour from August 16, 2015 through July 31, 2016.


4. The total number of hours expended on this litigation by my firm from August 16, 2015 through July 31, 2016, is 38 hours. The total lodestar for my firm is \$14,900.00. My firm's lodestar figures are based on the firm's current hourly billing rates. The hourly rates for the partners, attorneys and professional support staff in my firm are the same as the usual and customary hourly rates charged for their services in contingent billable matters. The total hours was determined by the examination of contemporaneous, daily time records regularly prepared and maintained by my firm and which have been provided to co-lead counsel for their review.

5. As detailed in Exhibit 2, my firm has incurred a total of \$3,000.47 in unreimbursed expenses during the period August 16, 2015 through July 31, 2016.

6. The expenses incurred in this action are reflected on the books and records of my firm. These books and records are prepared from expense vouchers, check records and other source materials and represent an accurate recordation of the expenses incurred.

I declare under penalty of perjury under the laws of the United States of America that the foregoing is true and correct.
