PLEASE TAKE NOTICE that the Court, in its discretion, may hold a hearing, on a date and time to be determined by the Court, to consider Plaintiffs' motion to authorize the distribution of the Round 1 and Round 2 settlement funds to claimants and amend the Plan of Allocation. Please take further notice that if the Court sets such a hearing, the date and time set by the Court will be posted on www.freightforwardcase.com.

Plaintiffs move the Court for entry of an order to authorize the distribution of the Round 1 and Round 2 settlement funds to qualified claimants who made qualifying purchases of freight forwarding services, and to amend the Plan of Allocation to allow for \$25 minimum payments to those qualified claimants whose *pro rata* award was less than \$25. In support of their Motion, Plaintiffs submit a Memorandum of Law, Declaration of Kevin L. Skenandore, Declaration of Daniel C. Hedlund, and a proposed order, attached to this Notice.
