**DECLARATION OF WILLIAM F. FLAHAVAN IN SUPPORT OF  
PLAINTIFFS' REVISED PETITION FOR ATTORNEYS' FEES  
AND REIMBURSEMENT OF EXPENSES FILED ON BEHALF OF  
FLAHAVAN LAW OFFICES**

I, WILLIAM F. FLAHAVAN, declare and state as follows:

1. I am a principal of the law firm of Flahavan Law Offices. I submit this Declaration in support of Plaintiffs' petition for an interim award of attorneys' fees and reimbursement of costs and expenses in connection with services rendered and expenses incurred by my firm in connection with this litigation.

2. My firm has acted as counsel to Plaintiffs and the Plaintiff class in this class action. During the period inception through August 15, 2015, and at the request of Plaintiffs' Co-Lead Counsel, my firm has been involved in the following activities on behalf of the Plaintiffs: This office assisted in the representation of Plaintiff Anything Goes, LLC d/b/a Mail Boxes Etc. in the above-referenced litigation. Our representation included initial communications between the client regarding the responsibilities of Plaintiff as Class Representative and, upon the agreement of Anything Goes to act as Class Representative, this office assisted Anything Goes in providing Co-Lead Counsel with information and

documentation to establish Anything Goes as an appropriate Class Representative. Thereafter from November 6, 2007 to the present, this office has assisted Anything Goes in providing Co-Lead Counsel with information and documentation necessary to the effective pursuit of this litigation.

3. The schedule attached hereto as **Exhibit 1** is a detailed summary indicating the amount of time spent by the partners, attorneys and other professional support staff of my firm who have been involved in this litigation, and the lodestar calculation is based on my firm's current hourly billing rates except for work done on document review which is capped at \$400 per hour from inception through August 15, 2015 except for time submitted in the first interim fee petition filed on September 10, 2013

4. The total number of hours expended on this litigation by my firm from inception through August 15, 2015, excluding the hours submitted in the first interim fee petition filed on September 10, 2013, is 197.40 hours. The total lodestar for my firm is \$36,102. My firm's lodestar figures are based on the firm's current hourly billing rates. The hourly rates for the partners, attorneys and professional support staff in my firm are the same as the usual and customary hourly rates charged for their services in contingent billable matters. The total hours was determined by the examination of contemporaneous, daily time records regularly prepared and maintained by my firm and which have been provided to co-lead counsel for their review.

5. As detailed in Exhibit 2, my firm has incurred a total of \$0.00 in unreimbursed expenses during the period inception through August 15, 2015, not counting the expenses submitted in the firm interim fee petition dated September 10, 2013.

6. The expenses incurred in this action are reflected on the books and records of my firm. These books and records are prepared from expense vouchers, check records and other source materials and represent an accurate recordation of the expenses incurred.

I declare under penalty of perjury under the laws of the United States of America that the foregoing is true and correct.
